## Philip Morris ČR a.s. Reports Mid-2020 Financial Results

Philip Morris ČR a.s. reports consolidated revenues of CZK 8.6 billion and net income of CZK 1.7 billion for the first half of 2020.

## Highlights for the half-year ended June 30, 2020 include:

- Consolidated revenues, net of excise tax and VAT, increased by 4.7% (or 3.8% excluding the impact of currency) to CZK 8.6 billion
- Consolidated net income decreased by 14.2% to CZK 1.7 billion
- Heated tobacco products shipments increased by 0.4 billion to 1.2 billion in the Czech Republic and Slovakia, combined
- Total shipments volume decreased by 0.2 billion to 6.2 billion

The estimated combined market share of cigarettes and heated tobacco products in the Czech Republic increased by 3.5 share points with *HEETS* advancing by 4.1 share points in the first half of 2020, compared to the same period in 2019. The estimated total combined market of cigarettes and heated tobacco products in the Czech Republic decreased by 11.5%.

In Slovakia, the estimated combined market share increased by 0.2 share points with *HEETS* advancing by 2.7 share points. The estimated total combined market of cigarettes and heated tobacco products in Slovakia decreased by 1.3%.

"In these extraordinary and unprecedented circumstances caused by the global COVID-19 pandemic, our primary concern continues to be the safety of our employees, their families, our partners as well as our customers. At the same time, we are determined to remain a reliable and valuable partner to our communities. We feel proud of a direct and active participation of many of our colleagues, thanks to which we were able to quickly develop and implement several charity projects and initiatives that directly contributed to those in need."

"Despite the COVID-19 outbreak and the measures governments took to contain the spread of the virus, our performance remained solid. We estimate that as of July 30<sup>th</sup>, 2020, the number of total IQOS adult users<sup>1</sup> in both countries combined increased by 169,000 and reached 621,000 (448,000 in the Czech Republic and 173,000 in Slovakia). We are particularly pleased that out of them, 427,000 (306,000 in the Czech Republic and 121,000 in Slovakia) have stopped smoking and switched to IQOS<sup>2</sup>, which, while not risk-free, presents a better choice for their health compared to continuing to smoke cigarettes," said Andrea Gontkovičová, Chairperson of the Board and Managing Director of Philip Morris ČR a.s.
